Psychiatric Interview Analysis

Introduction: In this activity, you are to analyze therapeutic communication techniques used in a simulated patient interview. Please note that before proceeding make sure to go through and you have signed the non-disclosure agreement.

Learners objective:

At the end of the session, the learners should be able to:

1. Differentiate between therapeutic and non-therapeutic communication techniques in psychiatric interviews.
2. Critically analyze the effectiveness of therapeutic and non-therapeutic communication techniques in various psychiatric interview scenarios.
3. Reflect on strategies for using therapeutic communication to build rapport, elicit information, and provide support to patients in psychiatric settings.

Materials:

Procedure:

1. Watch the first 30 min. of the recorded video of the simulated patient interviews and do an analysis.
2. Identify 1 reporter from your group and report your findings in the plenary session. You are given 15 minutes to present.
